This Schedule 13G is being filed on behalf of (i) Mitchell P. Kopin, an individual who is a citizen of the United States of America (**Mr. Kopin**), (ii) Daniel B. Asher, an individual who is a citizen of the United States of America (**Mr. Asher**) and (iii) Intracoastal Capital LLC, a Delaware limited liability company (**Intracoastal**) and together with Mr. Kopin and Mr. Asher, collectively the **Reporting Persons**).

The Reporting Persons have entered into a Joint Filing Agreement, a copy of which is filed with this Schedule 13G as **Exhibit 1**, pursuant to which the Reporting Persons have agreed to file this Schedule 13G jointly in accordance with the provisions of Rule 13d-1(k) of the Securities Exchange Act of 1934, as amended.

(a) and (b):

(i) Immediately following the execution of the Securities Purchase Agreement with the Issuer on July 20, 2016 (the **SPA**) (as disclosed in the Form 8-K filed by the Issuer with the Securities and Exchange Commission on July 20, 2016), each of the Reporting Persons may have been deemed to have beneficial ownership of 501,254 shares of Common Stock, and all such shares of Common Stock in the aggregate represented beneficial ownership of approximately 6.4% of the Common Stock, based on (1) 7,291,841 shares of Common Stock outstanding as of July 19, 2016 as reported to the Reporting Persons by the Issuer, plus (2) 501,254 shares of Common Stock that were to be issued to Intracoastal at the closing of the transaction contemplated by the SPA. The foregoing excludes 375,941 shares of Common Stock issuable upon exercise of a warrant that was to be issued to Intracoastal at the closing of the transaction

contemplated by the SPA (the **Intracoastal Warrant**) because the Intracoastal Warrant contains a blocker provision under which the holder thereof does not have the right to exercise the Intracoastal Warrant to the extent that such exercise would result in beneficial ownership by the holder thereof, together with the holder's affiliates, and any other persons acting as a group together with the holder or any of the holder's affiliates, of more than 4.99% of the Common Stock. Without such blocker provision, each of the Reporting Persons may have been deemed to have beneficial ownership of 877,195 shares of Common Stock.

(ii) As of the close of business on July 27, 2016, each of the Reporting Persons may have been deemed to have beneficial ownership of 472,188 shares of Common Stock, which consisted of (i) 105,854 shares of Common Stock held by Intracoastal and (ii) 366,334 shares of Common Stock issuable upon exercise of the Intracoastal Warrant, and all such shares of Common Stock in the aggregate represent beneficial ownership of approximately 4.99% of the Common Stock, based on (i) 7,291,841 shares of Common Stock outstanding as of July 19, 2016 as reported to the Reporting Persons by the Issuer, plus (2) 1,804,512 shares of Common Stock that were issued at the closing of the transaction contemplated by the SPA, plus (3) 366,334 shares of Common Stock issuable upon exercise of the Intracoastal Warrant. The foregoing excludes 9,607 shares of Common Stock issuable upon exercise of the Intracoastal Warrant because the Intracoastal Warrant contains a blocker provision under which the holder thereof does not have the right to exercise the Intracoastal Warrant to the extent that such exercise would result in beneficial ownership by the holder thereof, together with the holder's affiliates, and any other persons acting as a group together with the holder or any of the holder's affiliates, of more than 4.99% of the Common Stock. Without such blocker provision, each of the Reporting Persons may have been deemed to have beneficial ownership of 481,795 shares of Common Stock.
