### **Item 2.03 Creation of a Direct Financial Obligation or an Obligation under an Off-Balance Sheet Arrangement of a Registrant**

As previously announced, on December 15, 2016, Fifth Third Bancorp ( Fifth Third ) entered into an accelerated share repurchase transaction with Deutsche Bank AG, London Branch ( Deutsche Bank ) pursuant to which Fifth Third would purchase approximately \$155 million of its outstanding common stock (the Repurchase ). Fifth Third is repurchasing the shares of its common stock as part of its 100 million share repurchase program previously announced in a current report on Form 8-K filed on March 16, 2016.

On February 2, 2017, Fifth Third was notified by Deutsche Bank that it had finished purchasing shares in connection with the Repurchase. A total of 4,843,750 shares were repurchased upon execution of the Repurchase agreement, and an additional 1,044,362 shares will have been repurchased upon completion of the agreement. The repurchase of the additional shares is expected to settle on Monday, February 6, 2017. In total, 5,888,112 shares will have been repurchased at an average price of \$26.3242 per share.

After the completion of the Repurchase, Fifth Third will have approximately 80.6 million shares of remaining repurchase authority under the aforementioned share repurchase program.

Deutsche Bank and certain of its affiliates have performed, and in the future may perform, various financial advisory and other services for Fifth Third and Fifth Third's affiliates for which they have received, and may in the future receive, customary fees and expenses.
