## Explanation of Responses:

- (1) Includes 37,500 shares of previously granted restricted stock which vests as follows: 15,000 on 11/1/2011; 11,250 on 11/2/2011; and 11,250 on 11/2/2013, all subject to continuous employment with the issuer.
- (2) The number of underlying securities is based on the stock fund balance on September 31, 2010. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a September 30, 2010, stock fund price of \$30.50 per share.
- (3) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
- (4) Each unit of phantom stock is the economic equivalent of one share of Johnson Controls common stock.
- (5) The phantom stock units were accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash upon the vesting of the reporting person's Restricted Stock Grant.
- (6) Includes 502.702 phantom stock units acquired through the reinvestment of dividends on April 5, July 2 and October 4, 2010, at prices ranging from \$26.88 to \$33.10 per phantom stock unit.
- (7) The 6.50% Convertible Senior Notes due 2012 are convertible at any time prior to the close of business on the second scheduled trading day immediately preceding September 30, 2012. The conversion rate for the notes is initially 89.3855 shares per \$1,000 principal amount of notes (equal to a conversion price of approximately \$11.19 per share of common stock), subject to adjustment, pursuant to the terms of the notes.
- (8) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. Shares of phantom stock are payable in cash following the reporting person's termination of employment with the company and may be transferred by the reporting person into an alternative investment account at any time.
- (9) The phantom stock units were accrued under the Johnson Controls Retirement Restoration Plan and are to be settled 100% in cash upon the reporting person's retirement.
- (10) Includes 185.956 phantom stock units acquired through the reinvestment of dividends on April 5, July 2 and October 4, 2010, at prices ranging from \$26.88 to \$33.10 per phantom stock unit. Also includes shares acquired through ongoing contributions.
