- (1) The transaction is disclosing a dividend that is exempt from reporting under Rule 16a.
 On December 4, 2013, the issuer declared a dividend, payable to all holders of record of common stock on December 16, 2013 (the "Dividend"). In accordance with the terms of the October 14, 2013 Restricted Stock Agreement, 55 additional shares of restricted stock were received by the reporting person in connection with the Dividend. The additional shares of restricted stock will vest as follows: (i) 27 shares will vest at a rate of 20% annually beginning on October 14, 2019; and (ii) 28 shares will vest at a rate of 20% annually beginning on October 14, 2019, but shall immediately vest if the market price of the issuer's common stock exceeds \$35.00 per share for a period of 10 trading days, which need not be consecutive.
- (3) Includes 11,191 shares of restricted stock.
- (4) Represents 1,988 shares of restricted stock that will vest at a rate of 20% annually beginning on January 2, 2015.
- (5) Represents 13,179 shares of restricted stock.
