(1) Includes 35,250 shares of restricted stock which vests as follows: 22,500 on 1/3/2010, and 12,750 on 11/1/2011.

The number of underlying securities is based on the stock fund balance on October 30, 2009. The actual number of shares issuable upon
(2) the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on an October 30, 2009, stock fund price of \$23.92 per share.

(3) Each unit of phantom stock is the economic equivalent of one share of Johnson Controls common stock.

The phantom stock balance consists of an award of 19,000 restricted stock units granted on November 2, 2009, which vest as follows:
(4) 9,500 on November 2, 2011, and 9,500 on November 2, 2013. The phantom stock units representing the award and the dividends which accrue during the restrictive period are to be settled 100% in cash, pending vesting.

(5) The phantom stock units were accrued under the Johnson Controls Retirement Restoration Plan and are to be settled 100% in cash upon the reporting person's termination of employment with the company.

Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. The restricted stock units were
(6) accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash, pending vesting.

(7) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
