## Explanation of Responses:

- (1) Includes 27,000 shares of previously granted restricted stock which vest as follows: 13,500 on November 2, 2011, and 13,500 on November 2, 2013, subject to continuous employment with the issuer.
- (2) The number of underlying securities is based on the stock fund balance on September 30, 2010. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on a September 30, 2010, stock fund price of \$30.50 per share.
- (3) Fifty percent of the options become exercisable two years after the grant date; the remaining 50%, three years after grant date.
- (4) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. Shares of phantom stock are payable in cash following the reporting person's termination of employment with the company and may be transferred by the reporting person into an alternative investment account at any time.
- (5) The phantom stock units were accrued under the Johnson Controls Retirement Restoration Plan and are to be settled 100% in cash upon the reporting person's termination of employment with the company.
- (6) Includes 611,395 phantom stock units acquired through the reinvestment of dividends on January 4, April 5, July 2 and October 4, 2010, at prices ranging from \$26.88 to \$33.10 per phantom stock unit.
- (7) The phantom stock units were accrued under the Johnson Controls Long-Term Incentive Plan and are to be settled 100% in cash upon the reporting person's termination of employment with the company.
- (8) Includes 1,510,275 phantom stock units acquired through the reinvestment of dividends on January 4, April 5, July 2 and October 4, 2010, at prices ranging from \$26.88 to \$33.10 per phantom stock unit.
- (9) Each share of phantom stock is the economic equivalent of one share of Johnson Controls common stock. The restricted stock units were awarded under the Johnson Controls Executive Deferred Restricted Plan. The units are to be settled 100% in cash upon the reporting person's termination of employment with the company, subject to vesting provisions.
- (10) Includes 2,752,274 phantom stock units acquired through the reinvestment of dividends on January 4, April 5, July 2 and October 4, 2010, at prices ranging from \$26.88 to \$33.10 per phantom stock unit.
