Disposed of pursuant to Merger Agreement among Issuer, SEACOR Holdings Inc. ("SEACOR"), SBLK Acquisition Corp. and
(1) CORBULK LLC dated as of March 16, 2005 (the "Merger Agreement") in exchange for \$43,464.00 in cash and 2,927 shares of SEACOR common stock having a market value of \$64.30 per share on the effective date of the merger.

This option, which provided for vesting in four equal annual installments beginning February 24, 2004, was converted into an option to
(2) purchase 16,164 shares of SEACOR common stock for \$29.70 per share and receive \$240,000.00 in cash pursuant to the Merger Agreement.
