- Under the terms of the Key Employees' Deferred Compensation Program (the "Program"), the Reporting Person has chosen to make salary deferrals to an incentive account. On the first business day of each month, the amount of salary deferred to the Reporting Person's account during the previous month, plus any matching amounts, is converted into Units representing shares of The Brink's Company ("BCO") Common Stock and credited to the Reporting Person's account in accordance with the terms of the Program. Dividends are calculated and credited to the Reporting Person's total account balance in accordance with the terms of the Program.
- (1) The number of Units credited to the Reporting Person's account on the Transaction Date is based upon a share price of \$22.56, which is the average trading price of BCO Common Stock for the month of November 2008, calculated in accordance with the terms of the Program.
 - (2) Balance reflects additional Units credited to Reporting Person's account in connection with spin-off of Brink's Home Security Holdings, Inc.
 - (3) Units representing shares of BCO Common Stock were credited to the Reporting Person's account under the Program as a result of a dividend payment, in accordance with the terms of the Program.
 - (4) The number of Units credited to the Reporting Person's account on the Transaction Date is based upon a share price of \$20.40, which is the average trading price of BCO Common Stock for December 1, 2008, calculated in accordance with the terms of the Program.
