- (1) The shares of Series A Convertible Preferred Stock were issued upon conversion of a secured note in the aggregate amount of \$25,000, based on \$1.00 per share. The conversion was part of the private placement conducted by the Company to implement a note conversion and warrant exercise restructuring program as disclosed in the Current Reports on Form 8-K filed with the SEC on July 7, 2010 and July 20, 2010. Each share of Series A Convertible Preferred Stock is convertible, at any time, into 5 shares of common stock, par value \$0.001.
