Pursuant to the terms of the awards, 13,266, 5,166 and 1,000 of the restricted stock units will vest on March 31, 2013, 2014, and 2015 respectively, subject to the Company's satisfaction of certain performance criteria for each of the fiscal years ending December 31, 2012, 2013 and 2014, and further subject to continued employment through the vesting date. The performance criteria for 2011 were met, resulting in the vesting of 17,621 restricted stock units. Any units that do not vest will be forfeited.
