Nicholas Trust M may be deemed to be a member of 10% owner group because P.G. Nicholas Trust M has agreed to certain voting agreements and limitations on transfers of shares of Class A Common Stock and Class B Common Stock. P.G. Nicholas Trust M disclaims beneficial ownership of the securities reported herein except to the extent of its pecuniary interest therein.
