Based upon the Company's achievement with respect to the EBITDA performance criteria for 2017, 60% of the stock appreciation rights subject to such criteria vested, resulting in the vesting of 2,625 stock appreciation rights.
- (4) On February 25, 2015, the reporting person was granted 1,649 restricted stock units, vesting in two equal annual installments beginning on the second anniversary of the grant date.
