Any performance option that has not performance vested by March 10, 2023 shall be forfeited.
- (6) These options were granted on March 10, 2019. 50% of these options are scheduled to vest on December 31, 2020 and the remaining 50% are scheduled to vest on December 31, 2021.
 - (7) These restricted stock units were granted on March 10, 2019. 50% of these restricted stock units are scheduled to vest on December 31, 2020 and the remaining 50% are scheduled to vest on December 31, 2021.
