On June 28, 2005, the reporting person was granted an option to purchase 5,000 shares of common stock at an exercise price of \$18.00.

- (1) The option vests in five equal installments based on the achievement of certain annual performance benchmarks. The performance criteria for 2005 and 2006 were met, resulting in vesting of the option as to 2,000 shares, which number was adjusted to reflect the stock dividends that were issued on October 10, 2009, January 10, 2010, April 9, 2010 and July 9, 2010.
