- (1) Restricted Stock Units ("RSUs") converted to phantom stock units and deferred under the Company's Deferred Compensation Plan. The units are payable only in shares of Common Stock at the end of the deferral period.
  - (2) Each deferred phantom stock unit is equivalent to one share of Common Stock of The Hershey Company.
  - (3) Restricted Stock Units ("RSUs") granted on April 7, 2006 of which 187 RSUs vested on April 7, 2009. The remaining 187 units will vest on April 7, 2010. Once vested, RSUs may be: (1) settled in cash having a value equivalent to the closing price of Common Stock on the New York Stock Exchange on the day preceding the vesting date, in an equal number of shares of Common Stock, or in a combination of cash and Common Stock; or (2) deferred under the Company's Deferred Compensation Plan. RSUs deferred as phantom stock units are payable only in shares of Common Stock at the end of the deferral period. The reporting person has elected to defer payment of the RSU award in phantom stock units.
