- (1) Shares were sold pursuant to a 10b5-1 Trading Plan in order to raise funds to pay the required withholding tax pursuant to the vesting of RSUs.
- (2) The average price of \$179.5828 consists of the following blocks of shares: 1,222 at an average price of \$179.36 and 313 shares at an average price of \$180.45.
- (3) On February 21, 2012, the reporting person was granted performance restricted stock units, the vesting of which was subject to both continued service and the degree to which a relative Total Shareholder Return target was attained for the period January 1, 2012 to December 31, 2013. The Compensation Committee certified that the payout for this award would be 136.48% (out of a possible 200%) of the target units granted to the reporting person based on the degree to which Equinix outperformed the Russell 1000 Index.
