## **NOTICE TO THE MARKET**

Companhia de Saneamento Básico do Estado de São Paulo – Sabesp hereby informs its shareholders and the market in general that today it will make a presentation in the Public Hearing on the proposal for Sabesp's Extraordinary Tariff Revision, pursuant to Arsesp's Preliminary Technical Note RTS/003/2015, in which it should present as the Company's proposal a total tariff increase of 22.70%, composed of 7.80%, related to the tariff adjustment based on the IPCA consumer price index, less the productivity factor, plus the remainder of the retroactive compensatory adjustment related to the first tariff revision and 13.82%, related to the extraordinary revision.

The Company's presentation has been filed with the CVM and is available on Sabesp's website, in the Investor Relations area.
