- (1) Includes 3.144 shares acquired through the reinvestment of dividends on March 31, 2005, at a price of \$55.9791 per share.

- (7) The restricted stock units were accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash upon the vesting of the reporting person's Restricted Stock Grant.
