**OCEAN RIG UDW INC. ANNOUNCES COMMON SHARES AND UNSECURED NOTES REPURCHASE PROGRAM**

Nicosia, Cyprus December 6, 2011 Ocean Rig UDW Inc. (NASDAQ: ORIG) (the Company or Ocean Rig ), a global provider of offshore deepwater drilling services, announced today that its Board of Directors has approved a repurchase program for up to a total of \$500.0 million in common shares of the Company and the Company's 9.5% senior unsecured notes due 2016. Common shares and unsecured notes may be purchased under the program from time to time through December 31, 2013.

Purchases by the Company will be made for cash in open market transactions at prevailing market prices or in privately negotiated transactions. The timing and amount of purchases under the program will be determined by management based upon market conditions and other factors.

The program does not require the Company to purchase any specific number or amount of Ocean Rig UDW common shares or unsecured notes and may be suspended without the Company's having purchased any common shares or unsecured notes or reinstated at any time in the Company's discretion and without notice.

**About Ocean Rig**

Ocean Rig is an international offshore drilling contractor providing oilfield services for offshore oil and gas exploration, development and production drilling, and specializing in the ultra-deepwater and harsh-environment segment of the offshore drilling industry. The company owns and operates 9 offshore ultra deepwater drilling units, comprising of 2 ultra deepwater semisubmersible drilling rigs and 7 ultra deepwater drillships, 3 of which remain to be delivered to the company during 2013.
