As of the close of business on October 10, 2017, the reporting persons and affiliates of the reporting persons beneficially owned an aggregate of 648,055 shares of the Issuer s Class A Common Stock or 5.1% of the Issuer s Class A Common Stock outstanding.

However, as of the close of business on October 17, 2017, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), beneficially owned 250,446 shares of the Issuer s Class A Common Stock (consisting of 150,446 shares of the Issuer s Class A Common Stock and listed options to purchase 100,000 shares of the Issuer s Class A Common Stock) and Integrated Assets II LLC, a Delaware limited liability company ("Integrated Assets II"), beneficially owned 315,157 shares of the Issuer s Class A Common Stock, which collectively represented 565,603 shares of the Issuer s Class A Common Stock or 4.5% of the Issuer s Class A Common Stock outstanding.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies and Integrated Assets II and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II.

Millennium Group Management LLC, a Delaware limited liability company ("Millennium Group Management"), is the managing member of Millennium Management and may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II.

Israel A. Englander, a United States citizen ("Mr. Englander"), controls the managing member of Millennium Group Management and may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II.

The foregoing should not be construed in and of itself as an admission by Millennium Management, Millennium Group Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies or Integrated Assets II, as the case may be.

#### (b) Percent of Class:

As of the close of business on October 17, 2017, Millennium Management, Millennium Group Management and Mr. Englander may be deemed to have beneficially owned 565,603 shares of the Issuer s Class A Common Stock or 4.5%

of the Issuer s Class A Common Stock outstanding (see Item 4(a) above), which percentage was calculated based on 12,600,418 shares of Class A Common Stock outstanding as of August 1, 2017, as per the Issuer s Form 10-Q dated August 4, 2017.
