First Eagle Investment Management, LLC (FEIM), an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is deemed to be the beneficial owner of 4,949,355 shares, or 21.69% of the common stock believed to be outstanding as a result of acting as investment adviser to various clients. Clients of FEIM have the right to receive and the ultimate power to direct the receipt of dividends from, or the proceeds of the sale of, such securities. 21 April Fund, Ltd. ("21 April"), a Cayman Islands company for which FEIM acts as investment adviser, may be deemed to beneficially own 3,322,615 of these 4,949,355 shares, which equates to 14.56% of the Common Stock. Additionally, FEIM disclaims beneficial ownership in 425,941 shares reported by FEIM which are held in separate accounts managed and voted by Michael M. Kellen in his individual capacity.
