On January 2, 2008, the company announced that on December 31, 2007, the Fuzing Segment's Dayron operation completed its previously reported sale of 40 millimeter assets to DSE, Inc., former owner of Dayron. The 40 millimeter assets, representing a non-core portion of the company's fuzing business, are comprised principally of equipment and inventory. The sale price was approximately \$4.5 million plus the value of inventory.
