(“Vaughan” or the “Company”) entered into a Sixth Amendment (“Amendment”) under its loan and security agreement (the “Loan Agreement”) with Avidbank Corporate Finance (formerly Peninsula Bank Business Funding, a division of Avidbank, a Division of Avidbank, f/k/a Peninsula Bank Business Funding, a division of the Private Bank of the Peninsula (“Avidbank”). Under the Amendment, the Company and Avidbank extended the maturity date of their revolving line of credit from June 25, 2011, to June 30, 2013
