Item 2.03 Creation of a Direct Financial Obligation or an Obligation under an Off-Balance Sheet Arrangement of a Registrant.

The Tennessee Valley Authority (“TVA”) entered into an agreement on December 18, 2012, to issue \$1.0 billion of TVA's 3.50% Global Power Bonds 2012 Series B due December 15, 2042 (the “Bonds”). The settlement date for the transaction is December 21, 2012. The Bonds bear a coupon rate of 3.50% and pay interest semi-annually on each June 15 and December 15, beginning June 15, 2013. The Bonds mature on December 15, 2042, and are not subject to redemption prior to maturity. After reflecting the transaction's discount and after deducting the fees of the managers, net proceeds to TVA are \$970,440,000, exclusive of out-of-pocket expenses incurred in connection with offering the Bonds.
