- (c) During the last five years JMT Resources Ltd. has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).
- (d) During the last five years, JMT Resources Ltd. was not a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

Item 3. Source and Amount of Funds or Other Considerations

Pursuant to a Contribution Agreement dated February 1, 2007, the Issuer issued 15,822,750 common shares of the Issuer to JMT Resources Ltd.

Item 4. Purpose of Transaction

JMT Resources Ltd. entered into the February 1, 2007 transaction and acquired the 15,822,750 common shares for investment purposes, but may transfer or sell such shares as necessary and in accordance with applicable securities laws.

JMT Resources Ltd. does not presently have any plan or proposal which relate to or would result in any of the following: the acquisition or disposition by any person of additional securities of the Issuer; an extraordinary corporate transaction involving the Issuer or its subsidiaries; a sale or transfer of a material amount of the Issuer's or its subsidiaries' assets; any material change in the present capitalization or dividend policy of the Issuer; any other material change in the Issuer's corporate structure; any changes to the Issuer's charter, bylaws or instruments corresponding thereto which may impede the acquisition of control by any person; causing a class of securities of the Issuer to be delisted from a national securities exchange or cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association; or a class of equity securities of the Issuer becoming eligible for termination of registration pursuant to section 12(g)(4) of the Securities Exchange Act of 1934.

Item 5. Interest in Securities of the Issuer

The aggregate number and percentage of common shares of the Issuer beneficially owned by JMT Resources Ltd. is 15,822,750 common shares, or approximately 28.9% of the Issuer, based on 68,129,310 common shares outstanding.

JMT Resources Ltd. has the sole power to vote or direct the vote, and to dispose or direct the disposition, of 15,822,750 shares of common stock of the Issuer.

Other than as described in Item 3 above, JMT Resources Ltd. has not effected any transaction in the shares of common stock of the Issuer in the past sixty days.

No person, other than JMT Resources Ltd., is known to have the right to receive or the power to direct the receipt of

dividends from, or the proceeds from the sale of, the 15,822,750 shares of common stock of the Issuer.

Except as set forth above or set forth in the exhibits, there are no contracts, arrangements, understandings or relationships between Reporting Persons and any other person with respect to any securities of the Issuer.
