(the “Registrant”) that become issuable (1) under the 2013 Equity Incentive Plan (the “2013 Plan”) and 2013 Employee Stock Purchase Plan (“2013 ESPP”) by reason of any stock dividend, stock split, recapitalization or other similar transaction effected without receipt of consideration that increases the number of the Registrant’s outstanding shares of common stock.

(2) For the sole purpose of calculating the registration fee, the amount to be registered under this Registration Statement has been broken down into two subtotals.

(3) Represents 1,076,380 additional shares of common stock available for issuance as a result of the annual evergreen increase pursuant to the 2013 Plan.

(4) Represents 215,276 additional shares of common stock available for issuance as a result of the annual evergreen increase pursuant to the 2013 ESPP.

(5) Estimated in accordance with Rules 457(c) and 457(h) solely for purposes of calculating the registration fee on the basis of \$17.85, the average of the high and low prices of the Registrant’s common stock as reported on The NASDAQ Global Market on March 2, 2017 (the “Full Offering Price”).

(6) Estimated in accordance with Rules 457(c) and 457(h) solely for purposes of calculating the registration fee on the basis of 85% of the Full Offering Price. Pursuant to the 2013 ESPP, the purchase price of the shares of common stock will be 85% of the lower of the fair market value of the common stock on the first trading day of the offering period or on the last day of the offering period.
