- (1) The reporting person was granted 10,368 shares of common stock as a result of the company's achievement of certain performance criteria for 2009/2010 (the award was originally allocated to the reporting person as performance-based restricted stock units). 50% of the shares vested on the date of grant and the remainder will vest on 3/1/12.
- (2) Represents shares reacquired to satisfy tax withholding obligations in connection with the vesting of (a) 21,000 shares of restricted stock granted to the Reporting Person on 3/2/09 (b) 4,688 shares of restricted stock granted to the Reporting Person on 3/1/10 and (c) 5,184 shares of restricted stock granted to the Reporting Person on 3/1/2011 (see footnote 1).
- (3) The option grant is subject to a four-year vesting schedule, vesting 12.5% on 9/1/11 and 1/48th per month thereafter.
- (4) Each restricted stock unit represents a contingent right to receive one share of eBay's common stock.
