- Restricted stock units granted pursuant to the Zoetis Inc. 2013 Equity and Incentive Plan. The restricted stock units vest as follows: 4,761 (1) restricted stock units will vest on February 23, 2015; 9,615 restricted stock units will vest on January 31, 2016; and 9,919 restricted stock units will vest on August 15, 2016; and 9,711 restricted stock units will vest on March 4, 2017.
- (2) Each restricted stock unit represents a contingent right to receive one share of Zoetis Inc. common stock.
