- (1) Restricted Stock Units (Common Stock equivalents) were granted pursuant to the WD-40 Company 2016 Stock Incentive Plan. The Restricted Stock Units (RSUs) will be settled solely with Issuer Common Stock upon an annual vesting schedule as provided for in the Award Agreement for the RSUs as follows: 34% not later than November 15, 2019, 33% not later than November 15, 2020, and 33% not later than November 15, 2021.
- (2) Acquisition of additional vested Market Share Units (Common Stock equivalents) upon certified performance vesting of Market Share Units (MSUs) awarded to the reporting person on October 12, 2015. Vested MSUs will be settled solely with Issuer Common Stock not later than November 15, 2018.
- (3) Total includes 1,271,575 shares held in WD-40 Company Profit Sharing Plan (Company Stock Fund) account. Total also includes 18,573 RSUs, of which 12,689 are subject to future vesting, 8,836 vested MSUs, and 967 vested Deferred Performance Units (Common Stock equivalents).
