DEREGISTRATION OF SECURITIES

This Post-Effective Amendment No. 1 to Form S-8 relates to the Registration Statement on Form S-8 (Registration No. 333-39298) (the “Registration Statement”) filed with the Securities and Exchange Commission (the “SEC”) on June 14, 2000 by G-III Apparel Group, Ltd. (the “Company”). The Registration Statement registered 250,000 shares of common stock, par value \$0.01 per share, of the Company (without giving effect to stock splits and dividends), to be offered and sold pursuant the G-III Apparel Group, Ltd. 1997 Stock Option Plan (the “Plan”). The Plan has expired by its terms and all stock options granted thereunder or governed thereby have either been exercised or expired unexercised.
