- (1) The sales reported in this Form 4 were effected pursuant to a Rule 10b5-1 trading plan.

- (9) The reporting person earned a total of 27,972 shares in respect of performance-based restricted stock units (PBRsUs) for the 2015-2016 performance period, which were granted to the reporting person as restricted stock units on 3/1/17.
