Pursuant to the instructions in Item 7 of Schedule 13G, Fidelity Management & Research Company ("Fidelity"), 82 Devonshire Street, Boston, Massachusetts 02109, a wholly-owned subsidiary of FMR Corp. and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 36,928,332 shares or 14.933% of the Class A Common Stock outstanding of Echostar Communications Corporation ("the Company") as a result of acting as investment adviser to various investment companies registered under Section 8 of

the Investment Company Act of 1940. The number of shares of Class A Common Stock of Echostar Communications Corporation owned by the investment companies at December 31, 2001 included 1,817,449 shares of Class A Common Stock resulting from the assumed conversion of \$82,585,000 principal amount of ECHOSTAR 4.875% CSD1/1/07 144A (22.007 shares of Class A Common Stock for each \$1,000 principal amount of debenture). The number of shares of Class A Common Stock of Echostar Communications Corporation owned by the investment companies at December 31, 2001 included 490,976 shares of Class A Common Stock resulting from the assumed conversion of \$22,310,000 principal amount of ECHOSTAR CONV 4.875% 1/01/07 (22.007 shares of Class A Common Stock for each \$1,000 principal amount of debenture). The number of shares of Class A Common Stock of Echostar Communications Corporation owned by the investment companies at December 31, 2001 included 3,731,112 shares of Class A Common Stock resulting from the assumed conversion of \$161,520,000 principal amount of ECHOSTAR 5.75% CSD5/15/08 144A (23.1 shares of Class A Common Stock for each \$1,000 principal amount of debenture).

Edward C. Johnson 3d, FMR Corp., through its control of Fidelity, and the funds each has sole power to dispose of the 36,928,332 shares owned by the Funds.

Neither FMR Corp. nor Edward C. Johnson 3d, Chairman of FMR Corp., has the sole power to vote or direct the voting of the shares owned directly by the Fidelity Funds, which power resides with the Funds' Boards of Trustees. Fidelity carries out the voting of the shares under written guidelines established by the Funds' Boards of Trustees.

Fidelity Management Trust Company, 82 Devonshire Street, Boston, Massachusetts 02109, a wholly-owned subsidiary of FMR Corp. and a bank as defined in Section 3(a)(6) of the Securities Exchange Act of 1934, is the beneficial owner of 1,178,283 shares or 0.476% of the Class A Common Stock outstanding of the Company as a result of its serving as investment manager of the institutional account(s). The number of shares of Class A Common Stock of Echostar Communications Corporation owned by the institutional account(s) at December 31, 2001 included 87,588 shares of Class A Common Stock resulting from the assumed conversion of \$3,980,000 principal amount of ECHOSTAR 4.875% CSD1/1/07 144A (22.007 shares of Class A Common Stock for each \$1,000 principal amount of debenture). The number of shares of Class A Common Stock of Echostar Communications Corporation owned by the institutional account(s) at December 31, 2001 included 177,817 shares of Class A Common Stock resulting from the assumed conversion of \$8,080,000 principal amount of ECHOSTAR CONV 4.875% 1/01/07 (22.007 shares of Class A Common Stock for each \$1,000 principal amount of debenture). The number of shares of Class A Common Stock of Echostar Communications Corporation owned by the institutional account(s) at December 31, 2001 included 8,778 shares of Class A Common Stock resulting from the assumed conversion of \$380,000 principal amount of ECHOSTAR 5.75% CSD5/15/08 144A (23.1 shares of Class A Common

Stock for each \$1,000 principal amount of debenture).

Edward C. Johnson 3d and FMR Corp., through its control of Fidelity Management Trust Company, each has sole dispositive power over 1,178,283 shares and sole power to vote or to direct the voting of 926,607 shares, and no power to vote or to direct the voting of 251,676 shares of Class A Common Stock owned by the institutional account(s) as reported above.

Members of the Edward C. Johnson 3d family are the predominant owners of Class B shares of common stock of FMR Corp., representing approximately 49% of the voting power of FMR Corp. Mr. Johnson 3d owns 12.0% and Abigail Johnson owns 24.5% of the aggregate outstanding voting stock of FMR Corp. Mr. Johnson 3d is Chairman of FMR Corp. and Abigail P. Johnson is a Director of FMR Corp. The Johnson family group and all other Class B shareholders have entered into a shareholders' voting agreement under which all Class B shares will be voted in accordance with the majority vote of Class B shares. Accordingly, through their ownership of voting common stock and the execution of the shareholders' voting agreement, members of the Johnson family may be deemed, under the Investment Company Act of 1940, to form a controlling group with respect to FMR Corp.

Fidelity International Limited, Pembroke Hall, 42 Crowlane, Hamilton, Bermuda, and various foreign-based subsidiaries provide investment advisory and management services to a number of non-U.S. investment companies (the "International Funds") and certain institutional investors. Fidelity International Limited is the beneficial owner of 287,330 shares or 0.116% of the Class A Common Stock outstanding of the Company. Additional information with respect to the beneficial ownership of Fidelity International Limited is shown on Exhibit B.

Pursuant to instructions in Item 7 of Schedule 13G, this Exhibit has been prepared to identify Fidelity International Limited, Pembroke Hall, 42 Crow Lane, Hamilton, Bermuda, a Bermudan joint stock company incorporated for an unlimited duration by private act of the Bermuda Legislature (FIL) and an investment adviser to various investment companies (the "International Funds") and certain institutional investors, as a beneficial owner of the 287,330 shares or 0.116% of the Class A Common Stock outstanding of Echostar Communications Corporation.

Prior to June 30, 1980, FIL was a majority-owned subsidiary of Fidelity Management & Research Company (Fidelity), a wholly-owned subsidiary of FMR Corp. On that date, the shares of FIL held by Fidelity were distributed, as a dividend, to the shareholders of FMR Corp. FIL currently operates as an entity independent of FMR Corp. and Fidelity.

The International Funds and FIL's other clients, with the exception of Fidelity and an affiliated company of Fidelity, are non-U.S. entities.

A partnership controlled by Edward C. Johnson 3d and members of his family owns shares of FIL voting stock with the right to cast approximately 39.89% of the total votes which may be cast by all holders of FIL voting stock. Mr. Johnson 3d is Chairman of FMR Corp. and FIL. FMR Corp. and FIL are separate and independent corporate entities, and their Boards of Directors are generally composed of different individuals. Other than when one serves as a sub adviser to the other, their investment decisions are made independently, and their clients are generally different organizations.

FMR Corp. and FIL are of the view that they are not acting as a "group" for purposes of Section 13(d) under the Securities Exchange Act of 1934 (the "1934" Act) and that they are not otherwise required to attribute to each other the "beneficial ownership" of securities "beneficially owned" by the other corporation within the meaning of Rule 13d-3 promulgated under the 1934 Act. Therefore, they are of the view that the shares held by the other corporation need not be aggregated for purposes of Section 13(d). However, FMR Corp. is making this filing on a voluntary basis as if all of the shares are beneficially owned by FMR Corp. and FIL on a joint basis.

FIL may continue to have the International Funds or other accounts purchase shares subject to a number of factors, including, among others, the availability of shares for sale at what FIL considers to be reasonable prices and other investment opportunities that may be available to the International Funds.

FIL intends to review continuously the equity position of the International Funds and other accounts in the Company. Depending upon its future evaluations of the business and prospects of the Company and upon other developments, including, but not limited to, general economic and business conditions and money market and stock market conditions, FIL may determine to cease making additional purchases of shares or to increase or decrease the equity interest in the Company by acquiring additional shares, or by disposing of all or a portion of the shares.

FIL does not have a present plan or proposal which relates to or would result in (i) an extraordinary corporate transaction, such as a merger, reorganization, liquidation, or sale or transfer of a material amount of assets involving the Company or any of its subsidiaries, (ii) any change in the Company's present Board of Directors or management, (iii) any material changes in the Company's present capitalization or dividend policy or any other material change in the Company's business or corporate structure, (iv) any change in the Company's charter or by-laws, or (v) the Company's common stock becoming eligible for termination of its registration pursuant to Section 12(g) (4) of the 1934 Act.

FIL has sole power to vote and the sole power to dispose of 287,330 shares.
