Pursuant to the instructions in Item 7 of Schedule 13G, Fidelity Management & Research Company ("Fidelity"), 82 Devonshire Street, Boston, Massachusetts 02109, a wholly-owned subsidiary of FMR LLC and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 14,411,638 shares or 3.310% of the Common Stock outstanding of JAMES HARDIE INDUSTRIES SE ("the Company") as a result of

acting as investment adviser to various investment companies registered under Section 8 of the Investment Company Act of 1940. The number of shares of Common Stock of JAMES HARDIE INDUSTRIES SE owned by the investment companies at December 31, 2010 included 13,839,738 shares of Common Stock resulting from the assumed conversion of 13,839,738 shares of JAMES HARDIE INDUSTRIES NV CDI (1 shares of Common Stock for each Unit Stock).

Edward C. Johnson 3d and FMR LLC, through its control of Fidelity, and the funds each has sole power to dispose of the 14,411,638 shares owned by the Funds.

Members of the family of Edward C. Johnson 3d, Chairman of FMR LLC, are the predominant owners, directly or through trusts, of Series B voting common shares of FMR LLC, representing 49% of the voting power of FMR LLC. The Johnson family group and all other Series B shareholders have entered into a shareholders' voting agreement under which all Series B voting common shares will be voted in accordance with the majority vote of Series B voting common shares. Accordingly, through their ownership of voting common shares and the execution of the shareholders' voting agreement, members of the Johnson family may be deemed, under the Investment Company Act of 1940, to form a controlling group with respect to FMR LLC.

Neither FMR LLC nor Edward C. Johnson 3d, Chairman of FMR LLC, has the sole power to vote or direct the voting of the shares owned directly by the Fidelity Funds, which power resides with the Funds' Boards of Trustees. Fidelity carries out the voting of the shares under written guidelines established by the Funds' Boards of Trustees.

Pyramis Global Advisors, LLC ("PGALLC"), 900 Salem Street, Smithfield, Rhode Island, 02917, an indirect wholly-owned subsidiary of FMR LLC and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 759,048 shares or 0.174% of the outstanding Common Stock of JAMES HARDIE INDUSTRIES SE as a result of its serving as investment adviser to institutional accounts, non-U.S. mutual funds, or investment companies registered under Section 8 of the Investment Company Act of 1940 owning such shares. The number of shares of Common Stock of JAMES HARDIE INDUSTRIES SE owned by the institutional account(s) at December 31, 2010 included 759,048 shares of Common Stock resulting from the assumed conversion of 759,048 shares of JAMES HARDIE INDUSTRIES NV CDI (1 shares of Common Stock for each Unit Stock).

Edward C. Johnson 3d and FMR LLC, through its control of PGALLC, each has sole dispositive power over 759,048 shares and sole power to vote or to direct the voting of 759,048 shares of Common Stock owned by the institutional accounts or funds advised by PGALLC as reported above.

Pyramis Global Advisors Trust Company ("PGATC"), 900 Salem Street, Smithfield, Rhode Island, 02917, an indirect wholly-owned subsidiary of FMR LLC and a bank as defined

in Section 3(a)(6) of the Securities Exchange Act of 1934, is the beneficial owner of 4,986,653 shares or 1.145% of the outstanding Common Stock of the JAMES HARDIE INDUSTRIES SE as a result of its serving as investment manager of institutional accounts owning such shares. The number of shares of Common Stock of JAMES HARDIE INDUSTRIES SE owned by the institutional account(s) at December 31, 2010 included 4,986,653 shares of Common Stock resulting from the assumed conversion of 4,986,653 shares of JAMES HARDIE INDUSTRIES NV CDI (1 shares of Common Stock for each Unit Stock).

Edward C. Johnson 3d and FMR LLC, through its control of Pyramis Global Advisors Trust Company, each has sole dispositive power over 4,986,653 shares and sole power to vote or to direct the voting of 4,285,263 shares of Common Stock owned by the institutional accounts managed by PGATC as reported above.

FIL Limited ("FIL"), Pembroke Hall, 42 Crow Lane, Hamilton, Bermuda, and various foreign-based subsidiaries provide investment advisory and management services to a number of non-U.S. investment companies and certain institutional investors. FIL, which is a qualified institution under section 240.13d-1(b)(1)(ii), is the beneficial owner of 11,853,819 shares or 2.722% of the Common Stock outstanding of the Company. The number of shares of Common Stock of JAMES HARDIE INDUSTRIES SE owned by the institutional account(s) at December 31, 2010 included 11,853,819 shares of Common Stock resulting from the assumed conversion of 11,853,819 shares of JAMES HARDIE INDUSTRIES NV CDI (1 shares of Common Stock for each Unit Stock).

Some or all of the shares of Common Stock of JAMES HARDIE INDUSTRIES SE owned by the investment companies at December 31, 2010 may include shares represented by American Depository Shares.

Partnerships controlled predominantly by members of the family of Edward C. Johnson 3d, Chairman of FMR LLC and FIL, or trusts for their benefit, own shares of FIL voting stock with the right to cast approximately 39% of the total votes which may be cast by all holders of FIL voting stock. FMR LLC and FIL are separate and independent corporate entities, and their Boards of Directors are generally composed of different individuals.

FMR LLC and FIL are of the view that they are not acting as a "group" for purposes of Section 13(d) under the Securities Exchange Act of 1934 (the "1934" Act) and that they are not otherwise required to attribute to each other the "beneficial ownership" of securities "beneficially owned" by the other corporation within the meaning of Rule 13d-3 promulgated under the 1934 Act. Therefore, they are of the view that the shares held by the other corporation need not be aggregated for purposes of Section 13(d). However, FMR LLC is making this filing on a voluntary basis as if all of the shares are beneficially owned by FMR LLC and FIL on a joint basis.

FIL has sole dispositive power over 11,853,819 shares

owned by the International Funds. FIL has sole power to vote or direct the voting of 10,357,604 shares and no power to vote or direct the voting of 1,496,215 shares of Common Stock held by the International Funds as reported above.
