J. W. Mays, Inc. today reported its financial results for the three months ended October 31, 2007.

Revenues for the three months ended October 31, 2007 amounted to \$3,477,207 compared to revenues of \$3,316,698, in the comparable 2006 three-month period.

Net loss for the 2007 three-month period amounted to (\$36,138), or (\$.02) per share, compared to net loss of (\$177,896), or (\$.09) per share, in the comparable 2006 three-month period.
