(2) These options become exercisable at the rate of 25% of the shares granted per year beginning on the first anniversary of grant.

In the circumstances of death, Disability or Retirement, these restrictions shall lapse on a pro-rata basis, provided that the minimum threshold has been achieved through fiscal 2009.
