Item 1. Security and Issuer

This statement on Schedule 13D relates to the acquisition of shares of common stock (the “Common Stock”) of Equus Total Return, Inc., a Delaware corporation (the “Company”) by Bertrand des Pallieres (hereafter, the “Reporting Person”) and an entity in which the Reporting Person beneficially holds a minority shareholding and serves as a director. The principal executive offices of the Company are located at Eight Greenway Plaza, Suite 930, Houston, Texas 77046.

Item 2. Identity and Background

This statement is being filed by the Reporting Person.

The Reporting Person’s business address is Eight Greenway Plaza, Suite 930, Houston, Texas 77046. The Reporting Person is a citizen of France. The Reporting Person’s principal present occupation is a private equity investor.

The Reporting Person has not, during the last five years, been convicted in a criminal proceeding. In addition, the Reporting Person has not, during the last five years, been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

Item 3. Source and Amount of Funds or Other Consideration

The source of the consideration provided in exchange for the Common Stock acquired by the Reporting Person consisted of personal funds.

Item 4. Purpose of Transaction

This filing is submitted in connection with the acquisition of 859,803 shares of Common Stock directly by the Reporting Person and 145,833 shares of Common Stock by SPQR Capital Holdings S.A., of which the Reporting Person serves as a director and a beneficial holder of 1/3 of its share capital. The Reporting Person has no present plans or proposals which related to or would result in any of the following:

- (a) the acquisition by any person of additional securities of the Company, of the disposition of securities of the Company;
- (b) an extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the Company or any of its subsidiaries;
- (c) a sale or transfer of a material amount of assets of the Company or any of its subsidiaries;
- (d) any change in the present board of directors or management of the Company, including any plans or proposals to change the number or term of directors or to fill any existing vacancies on the board;

- (e) any material change in the present capitalization or dividend policy of the Company;

- (f) any other material change in the Company's business or corporate structure, including but not limited to, any plans or proposals to make any changes in the Company's investment policy for which a vote is required by Section 13 of the Investment Company Act of 1940;

- (g) changes in the Company’s charter, bylaws or instruments corresponding thereto or other actions which may impede the acquisition of control of the Company by any person;
- (h) causing a class of securities of the Company to be delisted from a national securities exchange or to cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association;
- (i) a class of equity securities of the Company becoming eligible for termination of registration pursuant to Section 12(g)(4) of the Securities Exchange Act of 1934; or
- (j) any action similar to any of those enumerated above.

Item 5. Interests in Securities of the Issuer

(a) The Reporting Person directly and indirectly beneficially owns 3,022,934 shares of Common Stock, representing 28.62% of the issued and outstanding shares of Common Stock of the Company, which shares are held as follows:

(1) A Washington investment holding company wholly-owned by Versatile Systems Inc., a Canadian corporation of which the Reporting Person is a minority stockholder and serves as a director.

(3) A Luxembourg *société anonyme* of which the Reporting Person is a minority stockholder and serves as a director.

(4) The Reporting Person disclaims beneficial ownership to shares of Common Stock held thereby, except to the extent, if any, of the Reporting Person’s pecuniary interest therein.

The Common Stock directly and indirectly beneficially held by the Reporting Person represents approximately 8.62% of the issued and outstanding shares of Common Stock of the Company.

(b) The Reporting Person has the sole power to vote, or direct the vote, and dispose of, or direct the disposition of, 920,172 shares of Common Stock, which represents approximately 8.71% of the Company’s issued and outstanding shares of Common Stock. The Reporting Person has the shared power to vote, or direct the vote, and dispose of, or direct the disposition of, 2,102,762 shares of Common Stock, which represents approximately 19.91% of the Company’s issued and outstanding shares of Common Stock.

- (c) During the past 60 days, the Reporting Person has not purchased any shares of the Company.
- (d) No other person is known by the Reporting Person to have the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, the Common Stock beneficially owned by the Reporting Person.

(e) Not applicable.
