Item 4. Ownership

The aggregate number of Securities to which this Schedule 13G relates is 480,294 shares, representing 12.39% of the 3,875,166 shares outstanding. This latter number of shares is arrived by adding the number of shares reported as being

outstanding in the Issuer's most recent Form 10-K for the fiscal year ended September 30, 2015 (3,694,872) to the number of shares (180,294 shares) which would be receivable to the Reporting Persons if they were to convert all of the Issuer's Series A Convertible Preferred Stock held by them into common shares. The 3,875,166 shares outstanding used to calculate the Reporting Person's 12.39% ownership assumes no other shareholder converts their preferred stock to common.

In accordance with the policies and procedures of the Reporting Person, the proxy voting committee of the Reporting Person exercises in its sole discretion the entire voting power with respect to all shares of the Issuer held and to be held by the Reporting Person until such committee otherwise determines. Accordingly, the investment adviser to the Reporting Person has no voting authority but continues to have sole dispositive power over such shares.

As indicated in the response to Item 4, the investment adviser, Gabelli Funds, LLC, has sole dispositive power over all shares of the Issuer held by the Reporting Person.
