- (1) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 419 units were acquired at prices ranging from \$18.00 to \$21.92. These transactions are exempt under rule 16a-11.
- (2) During the fiscal year under a broker administered distribution reinvestment plan, 74 units were acquired at prices ranging from \$18.84 to \$21.84. These transactions are exempt under rule 16a-11.
