BHP BILLITON PLC - TRANSACTION IN SHARES

BHP Billiton Limited announces that on 29 November 2007 it purchased 1,075,000 ordinary shares of BHP Billiton Plc at an average price of 1,583.98 pence per ordinary share. The highest price paid was 1,613 pence per ordinary share and the lowest price paid was 1,554 pence per ordinary share.

Following the above transaction, BHP Billiton Plc holds 24,165,516 of its ordinary shares as treasury shares and BHP Billiton Limited holds 38,899,973 of the ordinary shares in BHP Billiton Plc, forming a total of 63,065,489 shares. The total number of BHP Billiton Plc ordinary shares in issue (excluding shares held as treasury shares and shares held by BHP Billiton Limited) is 2,218,093,573.
