Deregistration of Securities

Pursuant to a Registration Statement on Form S-3 (File No. 333-88712) initially filed with the Securities and Exchange Commission on May 21, 2002 and as amended (the "Registration Statement"), St. Mary Land & Exploration Company (the "Company") registered the resale from time to time of an aggregate principal amount of \$100,000,000 of the Company's 5.75% Senior Convertible Notes due 2022 (the "Notes") and 3,846,153 shares of the Company's common stock, \$0.01 par value per share (the "Common Stock"), issuable upon conversion of the Notes. The Notes and the shares of Common Stock issuable upon conversion of the Notes were registered to permit resales of such securities by certain selling securityholders named in the Registration Statement.

The Company is seeking to deregister all of the Notes and the shares of Common Stock that remain unsold under the Registration Statement as of the date hereof because its obligation to keep the Registration Statement effective pursuant to the terms of its registration rights agreement with the initial purchasers, for the benefit of the selling securityholders, has expired. Pursuant to the undertaking of the Company as required by Item 512(a)(3) of Regulation S-K, this Post-Effective Amendment No. 1 to the Registration Statement deregisters all securities registered that remain unsold pursuant to the Registration Statement at the termination of the offering.
