(1) These securities were held by the GLG Pleiade SICAV managed account, an account owned by a third-party client and in which none of GLG Partners LP (as investment manager for the managed account), GLG Partners Limited (as the general partner of GLG Partners LP) or Messrs. Pierre Lagrange, Noam Gottesman and Emmanuel Roman (as Managing Directors of GLG Partners Limited) have any ownership or pecuniary interest, and were sold pursuant to an instruction from the client to liquidate the managed account's holdings. Mr. Lagrange disclaims beneficial ownership of these securities and has no pecuniary interest therein, and this report shall not be deemed an admission that Mr. Lagrange is the beneficial owner of the securities for purposes of Section 16 or for any other purpose.

(2) These securities were sold as part of units, each consisting of one share of common stock and one warrant. The sale price for the unit was \$2.27.

(3) These securities were sold as part of units, each consisting of one share of common stock and one warrant. The sale price for the unit was \$2.29.

As discussed above in footnote (8), Mr. Lagrange disclaims beneficial ownership of these securities except to the extent of his pecuniary interest therein.

(10) Shares held indirectly by the trustee of the Lagrange GLG Trust through Point Pleasant Ventures Ltd. Mr. Lagrange has a pecuniary interest in these shares of Common Stock as a beneficiary of the Lagrange GLG Trust.

(11) Each warrant is exercisable for one share of common stock at any time commencing on or after December 21, 2007, provided that there is an effective registration statement in effect at such time covering the shares of common stock underlying the warrants.
