Pursuant to an investment management agreement, Sigma Management maintains investment and voting power with respect to the securities held by Sigma Capital Associates. Pursuant to an investment management agreement, SAC Global Investors maintains investment and voting power with respect to the securities held by Global Investments. Mr. Cohen controls each of SAC Capital Advisors Inc., Sigma Management and indirectly owns a 49% interest in the managing member of SAC Global Investors. As of December 31, 2012, by reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934, as amended, each of (i) SAC Capital Advisors LP, SAC Capital Advisors Inc. and Mr. Cohen may be deemed to beneficially own 969,117 ADS (constituting approximately 0.6% of the ADS outstanding); and (ii) SAC Global Investors and Mr. Cohen may be deemed to own beneficially 109,397 ADS (constituting approximately 0.1% of the ADS outstanding).
