(1) This amendment is being filed to correct the Form 3 filed with the Securities and Exchange Commission on July 6, 2015. The Class A common shares were acquired through the exercise of subscription rights by RSR, LLC, which exercised such subscription rights on June 29, 2015. Each such subscription right entitled its holder to purchase from the issuer one half of one Class A common share at a price of \$29.58 per whole Class A common share. The Class A common shares were omitted from the reporting person's original Form 3 due to an administrative error.

(2) The securities are held in the account of RSR, LLC, and may be deemed to be beneficially owned by Mr. Steinberg because he serves as the managing member of RSR, LLC. The reporting person disclaims beneficial ownership over such securities except to the extent of his pecuniary interest therein, and the inclusion of these securities in this report shall not be deemed an admission of beneficial ownership of the reported securities for purposes of Section 16 or for any other purposes.
