## Ezee ATM acquires the Meta-4 Business Networking Solutions from CGI

**Toronto, Ontario, July 7, 2004** Privately-held firm Ezee ATM LP has acquired Meta-4 Business Networking Solutions (MBNS) from CGI Group Inc. (CGI) (TSX: GIB.A; NYSE: GIB) for CDN\$5.6 million subject to certain adjustment clauses. MBNS provides cash dispensing services via a network of close to 700 automatic teller machines and point-of-sale terminals most of which are located in transportation venues, entertainment facilities and shopping centers in Quebec and Ontario.

In April 2004, CGI divested its assets in Meta-4 Technical Support Services. In doing so, and after today's announcement, CGI has completed all of its divestiture of Meta-4 assets.

Founded in 1976, CGI is among the largest independent information technology and business process services firms in North America. CGI and its affiliated companies employ approximately 25,000 professionals. CGI provides end-to-end IT and business process services to clients worldwide from offices in Canada, the United States, Europe, Asia Pacific as well as from centers of excellence in India and Canada. CGI's annualized revenue run rate is currently CDN\$3.8 billion (US\$2.8 billion) and at March 31, 2004, CGI's order backlog was CDN\$12.0 billion (US\$9.1 billion). CGI's shares are listed on the TSX (GIB.A) and the NYSE (GIB) and are included in the S&P/TSX Composite Index as well as the S&P/TSX Capped Information Technology and MidCap Indices.
