(1) This transaction was a cashless exercise of options to purchase 67,005 shares of Common Stock. The exercise price for the stock options was paid in the form of 54,670 shares of Common Stock owned by the Reporting Person valued at an aggregate of \$737,500 based on the \$13.49 closing price of Enzo Biochem's Common Stock on October 17, 2005, the exercise date.

(2) As of the date hereof, the Reporting Person directly beneficially owns 1,647,563 shares of Common Stock, 3,522 shares of Common Stock in Enzo Biochem's 401K plan and 468,217 options to purchase Common Stock, par value \$.01 per share which are currently exercisable. The Reporting Person also has an indirect beneficial interest in 614 shares in the name of his son and 1,671 shares that he holds as custodian for certain of his nephews.
