Item 1. Security and Issuer.

This Amendment No. 49 amends the Statement on Schedule 13D previously filed with
the SEC by Mr. Sumner M. Redstone and National Amusements, Inc. ("NAI") with
respect to the voting common stock, \$.50 par value per share (the "Common
Shares"), of WMS Industries Inc. (the "Issuer") as follows:

Item 5. Interest in Securities of the Issuer.

- (a) NAI is currently the beneficial owner, with shared dispositive
and no voting power of 3,483,900 Common Shares, or approximately
11.12%, of the issued and outstanding Common Shares of the Issuer
(based on the number of Common Shares that were reported to be
issued and outstanding as of May 9, 2005).
- (b) Mr. Sumner M. Redstone is currently the beneficial owner, with
sole dispositive and no voting power, of 800,000 Common Shares,
or approximately 2.55%, of the issued and outstanding Common
Shares of the Issuer (based on the number of Common Shares that
were reported by the Issuer to be issued and outstanding as of
May 9, 2005). As a result of his stock ownership in NAI, Mr.
Sumner M. Redstone is deemed the beneficial owner of an
additional 3,483,900 Common Shares of the issued and outstanding
Common Shares of the Issuer, for a total of 4,283,900 Common
Shares, or approximately 13.68%, of the issued and outstanding
Common Shares of the Issuer (based on the number of Common Shares
that were reported by the Issuer to be issued and outstanding as
of May 9, 2005).

The lack of voting power described in paragraphs (a) and (b) of
this Item 5 is pursuant to the Voting Proxy Agreement, described
in Item 6 of Amendment No. 19 of this Statement.

Pursuant to the terms of the Share Forward Transaction dated June 9, 2004, described in Amendment Number 37 to Schedule 13 D, on August 8, 2005 Mr. Sumner Redstone made partial settlement of such Share Forward Transaction. According to the terms of such Share Forward Transaction, within 3 business days of August 8, 2005, Mr. Sumner Redstone delivered 100,000 of Issuer's shares and made a cash payment of \$8,000 to Buyer.

Pursuant to the terms of the Share Forward Transaction dated June 9, 2004, described in Amendment Number 37 to Schedule 13 D, on August 11, 2005 Mr. Sumner Redstone made partial settlement of such Share Forward Transaction. According to the terms of such Share Forward Transaction, within 3 business days of August 11, 2005, Mr. Sumner Redstone delivered 100,000 of Issuer's shares and made a cash payment of \$263,000 to Buyer.

Pursuant to the terms of the Share Forward Transaction dated June 9, 2004, described in Amendment Number 37 to Schedule 13 D, on August 16, 2005 Mr. Sumner Redstone made partial settlement of such Share Forward Transaction. According to the terms of such Share Forward Transaction, within 3 business days of August 16, 2005, Mr. Sumner Redstone delivered 100,000 of Issuer's shares and made a cash payment of \$222,000 to Buyer.

Pursuant to the terms of the Share Forward Transaction dated June 29, 2004, described in Amendment Number 38 to Schedule 13 D, on September 8, 2005 Mr. Sumner Redstone made partial settlement of such Share Forward Transaction. According to the terms of such Share Forward Transaction, within 3 business days of September 8, 2005, Mr. Sumner Redstone delivered 100,000 of Issuer's shares and made a cash payment of \$391,000 to Buyer.

Pursuant to the terms of the Share Forward Transaction dated June 29, 2004, described in Amendment Number 38 to Schedule 13 D, on September 15, 2005 Mr. Sumner Redstone made partial settlement of such Share Forward Transaction. According to the terms of such Share Forward Transaction, within 3 business days of September 15, 2005, Mr. Sumner Redstone delivered 100,000 of Issuer's shares and made a cash payment of \$541,000 to Buyer.
