("Western") and Inland Diversified Real Estate Trust, Inc. ("Diversified") in accounts managed by Inland Investment Advisors, Inc. ("IIAI"). Mr. Goodwin directly and indirectly owns shares of American, Western and Diversified and disclaims beneficial ownership of shares owned by American, Western and Diversified except to the extent of his respective ownership of those entities.

(2) Includes 1,361,507 shares of common stock owned by Mr. Goodwin and/or his spouse. Also includes common stock owned directly by the following entities: 843,820 by American; 315,820 by Western; 10,000 by Diversified; 9,091 by The Inland Group Inc. ("TIGI"); 191,557 by IMIC stock Holding Company ("IMIC"); 7,212,118 by Inland Investment Stock Holding Co. ("IISHC"); 137,110 by Partnership Ownership Corp ("POC"); and 1,103,384 by Eagle Financial Corp. The latter four entities and Inland Real Estate Investment Corp ("IREIC") are wholly owned subsidiaries of TIGI. IIAI, IISHC and POC are wholly owned subsidiaries of IREIC. Mr. Goodwin is the controlling shareholder of TIGI and he disclaims beneficial ownership of shares owned by TIGI and its subsidiaries except to the extent of his respective ownership of those entities.
