Registrant incurred a net loss of \$3,646,000 for the year ended June 30, 2002. Final consolidated results of operations for the corresponding period of the current fiscal year have not yet been completed. However, during this time the Company incurred a discharge of indebtedness of \$3,975,000, as a result of emerging from Chapter 11 bankruptcy proceedings. Also, during the year ended June 30, 2003, the Company acquired/purchased certain subsidiary companies. The Company is in the process of obtaining accurate financial statements for these recently acquired companies.
