The Restricted Stock Units were granted under the 2011 Stock Incentive Plan of Honeywell International Inc. and its Affiliates (the 2011 Plan) and will vest on February 15, 2017, subject to a maximum up or down adjustment of 30% based on Honeywell's total shareowner return (TSR) relative to its compensation peer group of companies over both a 1-year period (August 1, 2014 to July 31, 2015) and 30-month period (July 1, 2014 to December 31, 2016). Pursuant to its authority under the 2011 Plan, with respect to up to 50% of the final award, the Committee has delegated to the CEO the authority to make a determination as to whether Mr. Fradin has achieved a satisfactory level of performance.
