As of the close of business on April 27, 2011, each of the Reporting Persons may be deemed to have beneficial ownership of 840,336 shares of Common Stock, and all such shares of Common Stock represent beneficial ownership of approximately 8.0% of the Common Stock, based on (1) 8,834,535 shares of Common Stock issued and outstanding on April 15, 2011 as disclosed in the Form 424B5 Prospectus Supplement filed by the Issuer on April 18, 2011, plus (2) 1,680,672 shares of Common Stock in the aggregate issued on April 21, 2011 at the closing of the transaction described in the Form 8-K filed by the Issuer on April 18, 2011. The foregoing excludes 588,235 shares of Common Stock issuable upon exercise of a warrant issued to Iroquois Master Fund Ltd. at the closing of the transaction described above (the Warrant) because the Warrant is not exercisable until the six (6) month anniversary of the date of issuance (and the Warrant also contains a blocker provision under which the holder thereof does not have the right to exercise the Warrant to the extent (but only to the extent) that such exercise would result in beneficial ownership by the holder thereof or any of its affiliates, of more than 4.9% of the Common Stock). Without such blocker provision (and assuming the Warrant is currently exercisable), each of the Reporting Persons may be deemed to have beneficial ownership of 1,428,571 shares of Common Stock.
